The Hydrant Programme is a national policing operation forming part of the National Police Chiefs' Council Child Protection and Abuse Investigation portfolio.

We provide support and guidance to forces on all aspects of child protection including contemporary and non-recent child sexual abuse and exploitation.

Within the Hydrant Programme there are teams who specialise in Research and Analysis, Peer Review and Peer Support and Media and Communications. Specific support can be provided to forces or individual officers and police staff in many ways, so please do get in touch to find out how Hydrant can help.

Peer Review, Peer Support and Debrief

Free of charge Peer Review, Peer Support (PRPS) and Debrief services.

Our experienced, qualified Review Officers are supported by a cadre of national SIOs with lived experience of child protection and investigation. The team is able to draw upon subject matter experts including victim and survivor advocates, psychologists advising on trauma informed practices, specialist communications and media experts and national disclosure and interview leads.

This is a supportive process for investigators and police staff of all levels to enhance investigations. The service can be adapted to suit the needs of anyone who will benefit from working with us.

Peer Review – is a formal process working to a set Terms of Reference, agreed with the commissioning force. At the conclusion of the review, a summary report is submitted to the force with any recommendations.

Peer Support – is a more informal process, not requiring an approved Terms of Reference. Officers and police staff can access support to discuss, benchmark and compare various elements of an investigation against national best practice.

Debrief – sessions identify learning and promising practice to be applied within force and across national policing. Recommendations will be provided.
